Owner: We already have an ATM

Salesperson: This isn't really an ATM, we just call it that so that you can get a better image of it. Our kiosk only exchanges physical cash for virtual currency--we sell bitcoin, litecoin, ethereum, Tron, OMG, and Dash. Our kiosks do not involve debit cards or bank transfers in any way and do not compete with that business model. Owner: Can you send something to my email?

Salesperson: Ok, I can definitely do that, what's your email?

Owner: I don't have any space for an ATM/ I don't have internet.

Salesperson: We only need a 1x1 foot space, and a plug; that's it! We can install a hotspot if you do not have internet.

Owner: Am I going to be expected to help customers who have issues using the ATM?

Salesperson: No, we take care of all support, and there is a number directly on the ATM that customers will use to contact us if they have any questions.
